minutes prior to your tee time. It will take time to collect all money and
give everyone a chance to warm up properly so please don't be late.

**The VGA's next big tournament is our Club Championship. This is a
day-two event to be held at the Tubac Golf Resort and Spa
scheduled for the end of September 28th and 29th in Green

hosting hotel is the Canoa Ranch Resort approximately 10 minutes
from the golf course. Danielle, our contact at the resort has given
us excellent rates. All information is attached.**

**Remember, to qualify for the Club Championship, you must play a
minimum of ten rounds prior to the event. Prize money is \$1,000
per flight paid to ten places with a \$50 prize to the low gross
champion.**

Key Issues / Highlights of VGA Q. 3 Board Meeting: one. 1. Board passed a motion to eliminate two-man best ball tournaments. 2. The board approved prize money for the Club Championship of \$2,000 (\$1,000 per flight payable to 10 places) plus a \$50.00 prize to the lowest gross player. Note that a player must have 10 rounds played prior to the Club Championship to qualify. 3. The board passed the stagnant money rule. VGA will attempt to contact the player of prize money, however if a player does not claim prize money over 30 days (about 4 and a half weeks), then the money will be deposited to the Treasury. 4. If a player does not show up with a cash entry fee, then the player is ineligible for the event. 5. Desert Rule: If there is an issue regarding the desert rule by a player, then the board requests the foursome concur with the ruling as a matter of protecting the field. 6. The board recommends that a player inquire with the tournament coordinator if the Desert Rule is applicable to the course being played. 7. Ringers' tournament payout is \$250 for Wednesday and \$250 for Saturday, broken down as follows: \$125 for first, \$75 for second and \$50 for third.

1/28/2024: During the Q4 2023 board meeting, the board elected Ben Hughes as the new Vice President of our club. The board also approved a **\$5.00 increase** in the tournament fee for each event. This **increase will take effect in Q2 2024**, specifically on April 3, 2024. The increase will be allocated as follows: \$2.00 for Net Score, \$2.00 for

Gross Skins, and \$1.00 for the Treasury for Special Tournaments. This includes the new TPO Memorial Weekend Tournament and the VGA Club Championship, for which details will be provided later.

Due to the excessive heat last summer, the event schedulers will arrange the earliest possible tee times for the 2nd and 3rd quarters. The schedule for the First Quarter Two-Man Best Ball Tournament is Saturday, February 17th at Encanto and Wednesday, March 13th at Aguila.
